Deposits and Forms of Payment

A minimum deposit of 50% of the bride and bridal party's total balance is required to reserve the wedding date. This is a non-refundable deposit which can take the form of cash, all major credit cards, or Venmo. Your wedding date will not be guaranteed nor held until the contract and deposit have been received. Your deposit will be deducted from the wedding day balance, which will be due before the day of your wedding using one form of payment. Please note that the bride is responsible for all payments due pursuant to this contract.

Cancellation Policy

Cancellations can be made up to 90 days prior to the wedding date, although, your original deposit is non-refundable. If you cancel within 60 days of the wedding day, 100% of the total quote will be charged.

In the event the wedding must be canceled or rescheduled due to natural disaster, state of emergency or pandemic you may reschedule once without having to pay additional deposit. Canceling completely without a rescheduled date will result in being released from contract. Original deposit is still not refundable.

Head Count Changes

Cancellations to headcount can be made up to 60 days before the event date, and the bride is responsible for 100% of any services cancelled thereafter. Any last-minute additions to the headcount will only be added as time permits, although I will work to accommodate as much as possible. This helps to ensure that everyone is ready on-time, thus reducing stress on the bride.





Travel

Travel fees may be applied if:

- Travel is outside of Marco Island
- There is more than one travel location
- Overnight accommodations are needed
- Other unexpected travel expenses are needed i.e. tolls, parking, etc.

*Hair pricing does not include travel fees.

Other

Please note that wedding-party prices run per person, per service. Clipping on hair extensions, drying wet hair, or adding in accessories are all available for an additional cost. The stylist will need a designated space to set up when on location, and the bride is responsible for arranging this clear and appropriate area before the stylist arrives. The stylist will also require a table and chair near an electrical outlet in a low-trafficked area. Good lighting and a mirror are ideal. If services cannot be performed, due to insufficient working conditions or tardiness, all fees still apply.
